### NOTIFICATION

Sub: Re-engagement of Retired staff on monthly remuneration basis in exigencies of services on COFMOW, Indian Railway, New Delhi.

In terms of Railway Board's letter No. E(NG)II/2007/RC-4/CORE/1 Dated 16.10.2017 & 12.12.2017, it has been decided to fill up the vacancy of one Chief Typist (Pay Level 6) and one MCM /Electrical (Pay Level 6) in COFMOW by re-engagement of Staff who have retired from Indian Railways.

Therefore application of staff who have retired from Railway Service are called for to reach Personnel Branch, COFMOW on or before 17.09.2018

The following terms and conditions may kindly noted: -

- 1 The scheme is valid upto 01.12.2019
- 2 The re-engagement shall be strictly upto 01.12.2019 or attaining the age of 65 years or till the availability of regular candidates whichever is earlier.
- 3 Maximum upper age limit for re-engagement is 65 years as on 01.12.2019. No re-engaged employee should continue in service beyond 65 years of age.
- 4 The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 In case their work/conduct is found unsatisfactory.
- 5 The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement. Further employees retired under SRRS/LARGESS will not be eligible.
- 6 The re-engaged employees are entitled only for monthly remuneration i.e. reducing pension from his/her last pay drawn (i.e. Basic+ DA) at the time of retirement. The monthly remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.

- 7 The re-engaged employee will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.
- 8 The re-engaged employees are not entitled for any other benefit or facilities except the monthly remuneration.
- 9 The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 10 Re-engagement shall be subject to prescribed medical fitness for the relevant category.
- 11 Suitability/competency of the applicant shall be adjudged by nominated committee before their re-engagement.
- 12 Copy of any of the following documents should be attached with the application & it is Mandatory.
  - a. Service certificate.
  - b. Pensioner Identity Card
  - c. Pension Payment Order
- 13 The last date for submission of the application is 17.09.2018. Staff retired employees from Railways desirous for re-engagement, have to submit their application in the prescribed format at Annexure A in Personnel/ Dak Section of COFMOW on or before 17.09.2018
